Sub: O.A 1244/2024 titled Rumana Abbas Vs UT of J&K and Ors-Consideration Order thereof.

Whereas, the J&K Services Selection Board advertised the posts of Supervisor, Social Welfare Department vide Advertisement No. 02 of 2023 dated 08.12.2023; and

Whereas, the J&K Services Selection Board conducted the OMR based written examination on 23.06.2024 and notified the Result/Scoresheet for the post of Supervisor vide Notification No. JKSSB-COE/1/2024-06 (7480543) dated: 09.07.2024; and

Whereas, vide Notification No. JKSSB/COE/1/2024-06(7480543)/Rev. dated 03.10.2024, the revised result of written test for the post of Supervisor, Social welfare Department was notified as per the prescribed criteria notified in the Advertisement No. 02 of 2023 for the said post which is also reproduced as under: -

- i. 95 marks for Objective Type Multiple Choice Examinations (120 Marks scaled down to 95 Marks).
- ii. 05 Marks to the candidates having Home Science, Development/Sociology as one of the subjects.

Whereas, the J&K Services Selection Board notified the list of the eligible candidates falling in the consideration zone for Document Verification; and

Whereas, feeling aggrieved of non selection the applicant approached the Hon'ble (CAT) Tribunal by filing O.A 1244/2024 titled Rumana Abbas Vs UT of J&K and Ors seeking following relief:-

"To call the applicant for document verification for the post of Supervisor, Social Welfare Department advertised vide notification no. 02 of 2023 dated 08.12.2023 in view of her superior merit and consider her selection and appointment to the post of Supervisor."

Whereas, the Hon'ble Tribunal vide order dated 19.11.2024 disposed of the case with the following directions:-



“...Having regard to the case setup, coupled with the submissions made at bar, this Original Application is disposed of at the admission stage itself, without entering into the merits of the case, with direction to respondents to consider the case of the applicant for verification of her documents under the visually impaired category in the light of 43.75 marks secured by her in the written examination, besides her additional qualification of graduation in Sociology subject, for which five marks have been earmarked. The respondents shall pass a reasoned and speaking order, in this regard, and communicate the same to the applicant within a period of three weeks from today. Before taking any final decision in the matter, the applicant shall also be afforded opportunity of personal hearing...”

Whereas, the marks of the candidate/petitioner as notified in the revised result dated 03.10.2024 is as under: -

Whereas, the merit for Shortlisting/Document Verification is drawn out of 100 Marks (95+05) and the candidate has also been awarded 05 additional marks for having Sociology/child Development /Home Science as one of the subject. Further, the last cut-off merit for shortlisting for Document Verification under PWBDs (HCV, visual impairment) is **42.75** and the marks of the candidate is **39.64**, as such could not be shortlisted for document verification for the aforesaid post.

Now therefore, in view of aforesaid facts and in due deference to the Order dated 19.11.2024 passed by the Hon'ble Central Administrative Tribunal, Jammu Bench, the case of the applicant is considered in the Board and found devoid of any merits, hence rejected.
