Whereas, as per the Indent/Advertisement Notification, the prescribed qualification for the post is/was as follows:

"Diploma in Printing Technology from recognized Institute"

Further, ARI & Trainings Department vide Letter No. ARI/SP/14/2014 dated: 13.12.2021 clarified the prescribed qualification for the aforementioned post as:-

"Matric with three years Diploma in Printing Technology from AICTE approved Institute"

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid post among other posts of ARI & Training Department vide Advertisement Notification No. 05 of 2020 dated 24.12.2020 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per Indent was 27.02.2021; and

Whereas, the Jammu & Kashmir Services Selection Board (JKSSB) conducted written examination for the above mentioned post on 15.06.2025; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated: 04-08-2025, issued the result/Score Sheet of the candidates who appeared in the OMR Based Written Examination held on 15.06.2025 for the said post. Thereafter, schedule for Documents Verification (D.V.) of the Candidates falling under the consideration zone was notified vide Notification No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated: 24-09-2025 and Supplementary Document Verification (D.V.) vide No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated 07.10.2025; and

Whereas, the Selection Committee for preparing the selection to the aforementioned post was constituted vide Order No.01-SSB of 2026 dated 01.01.2026; and

Whereas, the provisional selection list for the aforementioned post prepared as per the merit/eligibility of the candidates and having regard to the extant rules /regulations was placed before the Board in its 338th Meeting held on 13.02.2026, which, after deliberations and consideration of the matter, approved its notification.
