Whereas, the JKSSB vide Notification No. JKSSB-COESEXAM/UT/10/2023-04 (7055504) Dated. 03.01.2025, issued an Advance Notice for holding the OMR based written Examination for these posts to be held on **02.02.2025** and after holding the exams, the Result/Score-sheet of the candidates was notified vide notification No. JKSSB-COESEXAM(UT)/03/2025-06 (7641035) dated: 15.04.2025; and

Whereas, the schedule of the Documents Verification (DV) of the candidates falling under the consideration zone were notified vide notification No JKSSB-COESEXAM(UT)/03/2025-06 (7641035) dated: 30.04.2025, followed by Supplementary Document Verification (DV) vide No. JKSSB-COESEXAM(UT)/03/2025-06 (7641035) dated: 13.06.2025.

Whereas, the Board has constituted a Selection Committee vide office **Order No. 221-SSB of 2025 dated 14.07.2025**, for preparing the Selection List. The Selection Committee so constituted has prepared the Provisional Selection List (along with Waiting List) in accordance with the Merit/Eligibility of the candidates and on the basis of principle of merit-cum-preference and the same was placed before the Board in its 348th Board Meeting held on 30.04.2026, which after deliberations and having regard to all the aspects of the selection, approved its notification; and

- iv.
