Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid post among other posts of Lieutenant Governor's Secretariat, Jammu and Kashmir vide Advertisement Notification No. 04 of 2025 dated 28.04.2025 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be

required as per indent was 18.06.2025; and

Whereas, the Jammu & Kashmir Services Selection Board (JKSSB) conducted written examination for the above mentioned post on 13.07.2025; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated 04.08.2025, issued the result/Score Sheet of the candidates who appeared in the OMR Based Written Examination held on 13.07.2025 for the said post. Thereafter, schedule for Documents Verification (D.V.) of the Candidates falling under the consideration zone was notified vide Notification No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated 24.09.2025 and Supplementary Document Verification (D.V.) vide No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated 07.10.2025; and

Whereas, the Selection Committee for preparing the selection to the aforementioned post was constituted vide Order No. 334-SSB of 2025 dated 28.10.2025 which was superseded and the committee was re-constituted vide order No. 389-SSB of 2025 dated: 15.12.2025; and

Whereas, the provisional selection list for the aforementioned post prepared as per the merit/eligibility of the candidates and having regard to the extant rules /regulations was placed before the Board in its 334th Meeting held on 02.01.2026, which, after deliberations and consideration of the matter, approved its notification.

regard shall necessarily include complete details of the candidate including Name, Address, Roll Number and an active Contact Number.
