Whereas, the Jammu & Kashmir Services Selection Board (JKSSB) conducted written examination for the above mentioned post on 16.02.2025 ; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/9/2025-06(7650128) dated 25/09/2025, issued the result/Score Sheet of the candidates who appeared in the OMR

Based Written Examination held on 16.02.2025 for the said post. Whereas, the Selection Committee for preparing the selection to the aforementioned post was constituted vide Order No. 68-SSB of 2026 dated 23.02.2026.; and
