Sir,

Regarding the captioned subject read with reference attached, I am directed to submit that the issue regarding the release of withheld recommendations in respect of the posts of Constable (Telecommunication), advertised vide Notification No. 01 of 2024 dated 16.07.2024 and finalized vide Notification No. JKSSB-Scry/38/2025-03 (E-7823188) dated 20.02.2026, was placed before the Board in its 344th meeting held on 27.03.2026.

During the course of the selection process, certain cases, particularly pertaining to candidates belonging to the OBC/OSC category, were kept withheld for want of clarity regarding the validity of their category certificates. The matter was accordingly taken up with the General Administration Department, which, vide its communication dated 03.03.2026, clarified that the nomenclature "OSC" having been substituted with "OBC" without exclusion of any community, the certificates issued under the earlier provisions, if otherwise valid, may be treated as admissible for the present recruitment.

The Board, after detailed deliberations and in light of the clarification so received, examined the withheld cases and observed that the candidature of seven (07) such OBC/OSC candidates is in order. The Board, therefore, approved the release of their recommendations. The Board also took note of two (03) additional cases wherein the

candidates had subsequently furnished the requisite documents and clarifications, and accordingly approved the release of their recommendations as well.

In view of the above decisions of the Board, it is requested that necessary action may kindly be taken at your end, please.
