Sir,

In reference to the above captioned subject, it is to inform that the J&K Services Selection Board, in its 260th Board Meeting, among other agenda items, deliberated various withheld case of Class-IV Selection notified vide No. SSB/Secy/Sel/Class-IV/2021/6202-09 dated 06.10.2022, and forwarded to your department vide letter No. SSB/Secy/Sel/Class-IV/2021/16273-78 dated 18.10.2022. The Board, taking note of the documents submitted by the candidates and fulfilling the deficiencies, decided to release the withheld recommendations in respect 08 (eight) candidates selected under Horizontal Reservation in ESM category.

Accordingly, I am directed to forward herewith the list of **eight candidates**, as per **Annexure-A** to this communication, whose withheld recommendations are cleared by the Board on account of fulfilling the deficiencies, for further necessary action at your end. The other terms and conditions as contained in the letter No. SSB/Secy/Sel/Class-IV/2021/16273-78 dated 18.10.2022, shall remain the same.

It is further submitted that the document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be responsibility of the Indenting Department/appointing authority. In case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceedings against such candidates may kindly be initiated

Further, the eligibility of the candidates in respect of the Minimum and Maximum qualification for these posts (10th and 10+2 respectively) has been accepted on the basis of self- declaration/affidavit submitted by these candidates and the appointing authorities shall satisfy themselves on this account before issuing


appointment orders. Besides, the Certificates produced by the candidates, on the basis of which they have been assigned additional weight-age, if any, may also be verified from the issuing authorities as the final merit has been determined on the basis of the written score and additional weight-age claimed by the candidates.

These recommendations shall be subject to the outcome of writ petition(s), if any, pending before any competent Court of Law.

Moreover, in terms of Government Order No.1003-JK (GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
