Whereas, subsequently new and material facts came into our notice regarding the recent developments made in the identical cases filed in Kashmir division titled as Services Selection Board v/s Naseer Ahmed Tarray and others bearing LPA No. 35/2019 C/W SWP No. 1442/2018, SWP No. 1495/2018, SWP No. 2125/2018, SWP No. 1907/2018, SWP No. 1545/2018, SWP No. 466/2019 and SWP No. 1477/2018, and it has deemed expedite to review the aforesaid order considering that the department of Law, Justice and Parliamentary Affairs vide communication No. Law-SC/9/2021-10 dated 02-06-2021 has accorded sanction to file Special Leave Petition before the Hon'ble Supreme Court of India for challenging the judgment dated 27-04-2021 passed by the Division Bench of Hon'ble High Court at Srinagar in all the clubbed matters.

Now therefore, in pursuance to the stand taken by the Services Selection Board in Special Leave Petitions filed before the Hon'ble Supreme Court in aforesaid cases, it is hereby ordered that the Government Order No. 234 SSB of 2021 dated 16-08-2021 regarding release of recommendation of the petitioner for appointment as Teacher, is kept in abeyance subject to final outcome of the Special Leave Petitions filed before the Hon'ble Supreme Court of India in all the similarly situated cases.
