NOTIFICATION

Whereas, the School Education Department (SED), vide No. Edu-I/322/2009 dated 15.12.2017, forwarded the requisition for the post of "Teacher" under direct recruitment, and advertisement notices were issued by JKSSB bearing No.(s) 6/2017/01 to 06/2017/14 dated 28.12.2017 (General Line) No.06/2017/15 to 06/2017/28 dated 28.12.2017 (Math/Science) No.06/2017/29 to 06/2017/42 dated 28.12.2017 for various Districts of the Jammu & Kashmir. JKSSB had declared results /provisional shortlists of the same on the dates indicated against each as under:

General Line Teacher	04.08.2018
Science /Math Teacher	26.06.2018
Urdu Teacher	03.07.2018

Whereas, JKSSB adopted the following criteria while making a selection:

B.Ed	05 marks
M.Ed	05 marks
PG	02 marks
M.Phil	01 marks
Ph.D after M.Phil	02 marks
Direct Ph.D	03 marks
Total	15 marks
Written Test	85 marks
Grand Total	100 marks

Whereas, it was stipulated in unambiguous and specific terms that:

"... Only those candidates will get preference points who have entered the requisite qualification in their form (by entering it in their profile before). If the same is not reflected in form, no preference points will be allocated, even if the candidates produce any such degree at a later stage"

Whereas, subsequent to the Notification of provisional selection list the applicants represented that due to the fault in the automated system meant for submission of application forms, they were not able to fill up and submit their application forms correctly as a result additional points were not allotted to them. Petitioner(s) had attributed this fault to JKSSB; and

Whereas, a writ petition titled Naseer Ahmad Tarray v/s Jammu & Kashmir Services Selection Board & Anr. in SWP No. 1496/2018, was filed, wherein the Hon'ble High Court of Jammu & Kashmir at Srinagar upon consideration of the matter on 09.07.2018, was pleased to pass the following Order:

"Viewed in the above context, it will be futile to keep the writ petition pending on Board. Accordingly the Writ petition along with connected MP(s) is disposed of with a direction to the respondents that they shall call the Petitioners for counseling, verify their documents and assess their grade in terms of documents so produced by them within a period of four weeks from the date certified date of this order is made available to the Respondents".

Whereas, JKSSB challenged the Order passed by the Hon'ble Single Judge before the Division Bench of the Hon'ble High Court. Hon'ble Division Bench clubbed various petitions of similar nature and decided the same vide judgment dated 27.04.2021. The operative part of the judgment is reproduced below:

"Accordingly, the appeals filed by the Board being LPA Nos.(i) 35/2019, (ii) 117/2019 and (iii) 237/2019, are dismissed along with all connected CMs therewith. Consequently, the connected writ petitions bearing SWP No's (i) 414/2019;(ii) 415/2019(iii) 831/2019;(iv) 1463/2018 ;(v) 1477/2018 (vi) 1495/2018;(vii) 1545/2018; (viii)1907/2018;(ix) 2453/2018;(X)466/2019; AND (XI) 1442/2018 along with Writ petitions bearing SWP No. 1496/2018; 1965/2018 and 2125/2018 -subject matter of the three appeals are allowed and the consideration order a passed by the Board in regard to the claim of the Writ petitioners, as impugned in any of the Writ petitions before us, shall stand quashed. The Board is directed to assign appropriate points to all the relevant qualifications omitted by the Writ petitioners in their online application forms, including the qualification of B.Ed, to the credit of the Writ petitioners, of course, in case the same have been acquired by these petitioners prior to the last cut of date of the Advertisement Notice concerned ; evaluate their merit on the basis of such award of points ; and redraw the final selection lists for the posts in question, accordingly . This exercise shall be undertaken and concluded by the Board expeditiously, and in any case, not latter than eight weeks from the date of this Order"

Whereas, a Special Leave Petition was filed before the Hon'ble Supreme Court of India against the aforesaid Order and the same was dismissed vide Hon'ble Court Order dated 11.02. 2022. The grievance of the petitioners is that the Orders passed by the Hon'ble Division Bench have not been implemented, as such are alleging that the respondents have committed Contempt of Court; and

Whereas, there was not any willful disobedience of Hon'ble Division Order however, Government of Jammu and Kashmir has taken a policy decision to withdraw all the posts advertised prior to 31 of October, 2019, as such J&K SSB was constrained to examining the case in light of said Administrative Council decision; and

Whereas, under pains of contempt proceeding, finally it was decided to implement the judgement; and

Whereas, JKSSB in terms of Hon'ble Division Bench orders was enjoined to evaluate the merit of the petitioners on the basis of award points and to redraw the final selection list. It is apposite to submit here that in terms of various interim orders, posts had been kept reserved by the Board and by the SDE/Directorate of Education at that point of time; and

Whereas, accordingly, Financial Commissioner (Additional Chief Secretary), School Education Department convened a meeting on 03.04.2025 to discuss the case CCP(D) NO. 55/2022 in SWP No. 415/2019 CCP(D) No. 56/2022 CCP(D) No. 57/2022 CCP(D) No. 59/2022 CCP(D) No. 29/2023, titled Shabir Ahmad Mir and others Vs Shri Arun Kumar Mehta & others wherein under following decisions were taken:

- That the Directorate of School Education, Kashmir shall provide the information/requisite documents to the J&K Service Selection Board within a period of five days from today.
- That the officers of School Education Department who are also members of the Committee framed by the Board vide Order No. 379-SSB of 2024 dated 06.11.2024 (Revalidation Committee) shall assist the Board in the case titled Shabir Ahmad Mir Vs Arun Kumar Mehta apropos to the Supreme Court's directions.
- The mandate of the Re-validation Committee framed by the Board vide above mentioned order be expanded to cover the proper disposal of the case in light of the Hon'ble Supreme Court's directions in the case.

Whereas, the mandate of the Committee framed by the Board vide Order No. 379-SSB of 2024 dated 06.11.2024 (Re-validation Committee) was extended to examination and implementation of the judgement passed by the Hon'ble Division Bench. The Committee submitted its report on 23.05.2025 and accordingly, vide letter No. JKSSB-

SD0SECY(KAS)/11/2024-03 (E-7448974) dated 27.05.2025, a copy of the final report of Committee was forwarded to SED; and

Whereas, the Hon'ble High Court of J&K vide order dated 01.08.2025 asked the respondents to expedite and abide by the orders of the Hon'ble Court. Following this, the J&K SSB vide office Order No. 243-SSB of 2025 dated 01.08.2025 reconstituted selection Committee/Document verification Committee modification of office orders No. 396-SSB of 2018 dated 20.08.2018 (Document Verification Committee) and No. 013-SSB of 2019 dated 08.01.2019 (Selection Committee Order), owing to transfer of officers in the said committee(s), and in compliance to the Hon'ble Court Order dated 04.08.2025 passed in CCP(D) No. 55/2022 in SWP No. 415/2019, CCP(D) No. 56/2022 CCP(D) No. 57/2022 CCP9D) No. 59/2022, CCP(D) No. 29/2023 titled Shabir Ahmad Mir & Ors Vs Shri Arun Kumar Mehta & Ors., by the Hon'ble High Court of Jammu & Kashmir and Ladakh as also the communication dated 31.07.2025 of School Education Department read with the decision of the Board taken in 311th meeting dated 01.08.2025 which is reproduced as under:

"In view of the order passed by Hon'ble High Court dated 04.08.2025 and communication dated 31.07.2025 of School Education Department, matter was deliberated in the Board, wherein reliance was placed on the reply of GAD to SED that matter need not to be placed before the Council of Ministers as per the Hon'ble Court order and that it should be taken up with the Law Department and JKSSB.

As such during deliberation it was decided that recommendation of the petitioners may be forwarded to SED for necessary action at their end subject to availability of posts. However, it was noted that Board may inevitably require some time for verification of documents of these petitioners in compliance to the judgment of the Hon'ble Division Bench, which in any case was decided to be done by Monday (04.08.2025) positively. It was decided that in addition to the issuance of notice to the petitioners, they be called telephonically as well.

The Committee constituted for the purpose shall seek the Documents from the petitioners) candidates and conclude the recommendation process of the petitioners within 2 days on top priority"

Whereas, in the meantime, case was again listed for hearing and upon consideration of the matter on 04.08.2025 Hon'ble High Court of J&K passed the following order:

Shri Ram Niwas Sharma, Commissioner/Secretary to Government, Department of School Education submits that Jammu & Kashmir Service Selection Board is in process of verification of the documents of 19 petitioners and the last date has been fixed for verification is 06.08.2025 and once the verification is completed, the appointment orders shall be issued in favour of 19 petitioners.

Whereas, the DV cum Selection Committee completed document verification and presented the case before the Board in its 303th meeting wherein following decision was taken:

"The board was apprised of the matter and the legalities involved therein. Board was also briefed about the overlapping degrees of 5 candidates. The board has decided that since 3 candidates have produced a sworn affidavit (1st class magistrate) wherein they acknowledge overlapping of their degrees and have forfeited their claim for the extra 2 marks of the overlapping degrees. These 3 candidates are still figuring in the select list despite non-inclusion of the extra 2 marks. The board decided to exclude the extra 2 marks (due to overlapping of degrees) and recommend their selection as such. Furthermore, the recommendation of the remaining 2 candidates be kept withheld for want of production of the validity/clarification document from University of Kashmir as done in the selection process for the similarly placed cases in 2020 for the same advertisement notification of 2017.

Regarding the 01 candidate (Mr.Saddam) having Bonafide certificate from colleges but belonging to reputed Barkatullah University Bhopal, the Board decided to clear his recommendation.

However, the candidate (Mr.Mehrajuddin) without any Bonafide shall be kept withheld for want of production of valid Bonafide certificate.

The remaining 12 clear recommendations be also immediately sent to SED for further course of action at their end.

Whilst this exercise would result in change in marks of some of these candidates in the merit list, who were called for document verification, in case of whom, the validity of extra marks for higher degree could not be proven. Therefore, the necessary amendments in the redrawn merit list shall also be made accordingly by the concerned section/committee".

Now therefore, in light of foregoing, the Revised selection list as per revised Merit of the candidates under SRO-202 for the post of General /Science & Math/ Urdu Teacher (Education Department), District Cadre Srinagar/Baramulla/ Budgam/ Bandipora/ Anantnag Advertised vide Notification No. 06/2017 under various items after the inclusion of petitioners are hereby notified as per **Annexures A-I** forming part of this notification. It is further notified that:

- (i) The above revised Selection List shall be subject to outcome of writ petition(s)/application(s), if any, pending adjudication before any competent court of law.
- (ii) The List shall also be subject to the outcome of such Inquiry, if any, involving any candidate(s), as figuring in this List.
- (iii) Formal recommendations to the concerned Indenting department shall be forwarded separately.
- (iv) The Selection of the candidate has been made on the basis of Self-declaration/ certificates submitted by him and if at any stage, it comes to light that he has submitted false information or has secured selection on the basis of fake documents/ certificates, the selection shall be liable to cancellation at any stage.
