Whereas, the J&K Services Selection Board, vide Notification No. JKSSB-PLAN/25/2022-03 dated 21.01.2023, notified the Final Selection List for 1524 posts of Junior Assistant/Cashier Clerk/Store Attendant/Cadrex Clerk/Computer-cum-Junior Assistant/Welfare Organizer, belonging to 22 departments; and

Whereas, the following applicants were selected as Junior Assistants against the Notification Nos. 01 of 2021 & 02 of 2021 for the item No (s) shown against each, however, their recommendations were kept withheld with the remarks as mentioned in the table :

Whereas, the last date for submission of application forms as notified in the application form was 24.03.2021 which was extended to 29.03.2021 later on; and

Whereas, the Document Verification Committee (DVC) encountered deficiencies in documents in respect to these candidates as under:

S. No.	Candidate's Name	Deficiencies noticed by the DV Committee
1	AAQIB GULZAR	His EWS certificate has been issued on 22.02.2020 and is valid upto 21.02.2021. The candidate's EWS is not valid on the cut-off date as per the Notification No. 02 of 2021.
2	FARHAN AMIN KHAN	His EWS certificate has been issued on 09.04.2021 and was valid upto 08.04.2022. The candidate's EWS is not valid on the cut-off date as per the Notification No. 01 of 2021.
3	OWAIS HASSAN	His RBA certificate has been issued on 27.04.2021 and was valid upto 26.04.2026. The candidate's RBA is not valid on the cut-off date as per the Notification No. 01 of 2021.
4	ZAKIR HUSSAIN MIR	His RBA certificate has been issued on 16.07.2021 and was valid upto 15.07.2026. The candidate's RBA is not valid on the cut-off date as per the Notification No. 02 of 2021.

The Document Verification Committee observed that the candidates were not in possession of valid and within date Category certificates, which is otherwise crucial.

Whereas, regulation 25 of the Jammu and Kashmir Service Selection Board (Business and Procedure) Regulations, 2022 provides as under:

"25. Every such Notification/Advertisement Notice shall, among other things, clearly specify:

a. the Cut-off Date i.e the last date for submission of application forms which shall also be last date for determining the eligibility of applicants..."

Whereas, the candidate namely Mr. Owais Hassan, S/o Gh Hassan Bhat approached the Hon'ble Central Administrative Tribunal with **O.A No. 342/2024 titled Owais Hassan Vs UT Of J&K and Ors.** wherein the Hon'ble Tribunal upon consideration of the matter on 30.05.2024 was pleased to pass an order, the operative portion whereof at paragraphs 4 and 5 reads as under:-

"04. In view of the limited prayer made by the learned counsel for the applicant, the respondents are directed to consider the claim of the applicant in light of the Judgements passed by the Hon'ble High Court as well as by this Tribunal especially Para 16 of the Hon'ble High Court Judgement and Para 9 of the CAT Judgement in accordance with law within six weeks from the date of receipt of a copy of this order, by passing a speaking order.

05. With this O.A No. 343/2024 is disposed of accordingly."

Whereas, the cases of these 04 candidates were placed in the 285th Board Meeting held on 15.10.2024, wherein, the Board deliberated on the issue and decided as under:

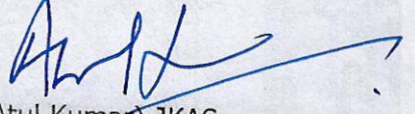
"The Board deliberated upon the matter and decided that though the issue in the aforesaid cases pertain to clubbing of separate notifications which ranged/ stretched to two calendar years, but the onus of filling the accurate details and opting for preferences as per the requisite eligibility of the post w.r.t various certificates, including category certificates, in the Application Form(s), falls squarely on the candidate himself/herself. Therefore, in such cases, the Board should follow the precedent and contest the cases appurtenant to the aforementioned issued in the appropriate forum."

Accordingly, the J&K Service Selection Board Vide Order No: 413- SSB of 2024 dated 12.12.2024 issued under endorsement No. JKSSB- LEG/500/2024-03 (7496082) dated 12.12.2024 in favour of Mr. Owais Hassan has decided as under:-

"with due deference to the order passed by the Hon'ble Central Administrative Tribunal, Srinagar Bench dated 30.05.2024, the case of the applicant is considered and the same is found to be legally not tenable and devoid of any merit, hence rejected"

Now therefore, with due deference to the order passed by the Hon'ble Central Administrative Tribunal, Srinagar Bench dated 30.05.2024 and in view of the decision of the Board in its 285th meeting held on 15.10.2024, the cases of the above mentioned applicants upon consideration are found devoid of any merit, hence rejected.
