Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. 03-Selection of 2025 dated 28th of February, 2025, issued under endorsement No. JKSSB-Scry/21/2024-03 (E-7623443), notified the Final Selection List for the Lab Assistant, Item No. 260, Division Cadre Jammu, Health and Medical Education Department advertised vide Notification No. 05 of 2015 dated 01.09.2015 and forwarded the recommendation of the selected candidates to the Health and Medical Education Department vide communication No. JKSSB-Scry/21/2024-03 dated 28.02.2025; and

Whereas, in the said selection list, the recommendations in respect of below mentioned candidates were kept withheld as the candidates have pursued a Degree in Medical Laboratory Technology, whereas, as per the original indent, the prescribed qualification for the post was **"10+2 with Diploma in Medical Laboratory Technician from a recognized institute."**
