Subject: OA No. 124/2026 titled *Rayees Ahmad Kumar vs Union Territory of J&K & Ors.* – Consideration order thereof.

Whereas, the applicant filed an Original Application (OA), bearing OA No. 124/2026 before the Hon'ble Central Administrative Tribunal (CAT), Srinagar Bench, and the Hon'ble CAT upon consideration of the matter on 25.02.2026, was pleased to pass an order, the operative portion whereof, is reproduced as under:

"7. In view of the limited prayer made by the learned Counsel for the applicant, and without commenting on the merits or otherwise of the matter, the respondents are directed to consider the representation dated 05.12.2025, of the applicant (Annexure-IV, page 35-36 of the O.A), for his selection in pursuance to Notification No. JKSSBCOE0EXAM(UT)/ 88/ 2023-03 (7314392) DATED 05.01.2024 in accordance with applicable rules and law, and as per his entitlement, provided no other legal impediment exist, by passing a speaking and reasoned order, within a period of two weeks from the date of receipt of certified copy of this order.

8. With this, OA No: 124/2026 is disposed of accordingly. No orders as to costs."

Whereas, the representation dated 05.12.2025 of the applicant was examined in the Board; and

Whereas, during the course of examination it came to the fore that JKSSB vide Advertisement Notification No. 01 of 2021 dated 03.02.2021 notified various posts including the posts of Screenman under various Item Numbers; and

Whereas the prescribed qualification for the instant post of Screenman, Item No. 157 was as under:

"Matric with diploma in electronics from ITI."

Whereas, applicant offered his candidature for the said posts and appeared in the OMR based written examination held on 05.11.2023 and was accordingly shortlisted for Document Verification (DV); and

Whereas, the Document Verification Committee (DVC) verified the documents submitted by the applicant during which it has come to the fore that the applicant, Rayees Ahmad Kumar has obtained his trade certificate from Think & Win Technologies Institute, Kulgam, the recognition status of which was suspect; and

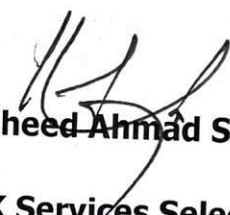
Whereas, the Board, to obtain clarification regarding the recognition status of the institute, took up the matter with Director Skill Development vide communication No. JKSSB-Scry/6/2024-03 (E-7417875) dated 22.05.2025, who in turn has conveyed as under:

"Think & Win Technologies Institute, Kulgam is neither registered or recognized with the of Skill Development, J&K, nor with the Board of Technical Education"; and

Whereas, in light of the clarification received, the applicant was not considered for the instant post.

Now, therefore, in view of the above and with due deference to the order dated 25.02.2026 passed by the Hon'ble Central Administrative Tribunal, Srinagar Bench, the representation of applicant upon being considered is found devoid of any merit and is disposed of as rejected.
