Kindly refer to this office letter No.SSB/Secy/Sel/2022/566-75 dated 03.08.2022 regarding the subject cited above, where-under the Selection List of Candidates for the post of Junior Engineer (Civil) in Public Works (R&B) Department, Division Cadre, Kashmir, advertised vide Notification No.05 of 2020 dated 24.12.2020, Item No.130, was forwarded to your department for further course of action.



Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, a candidate whose recommendation is released by the Selection Agency shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate shall forego his/her right to appointment forthwith.
